SECTION 1 – PURPOSE OF RFP

- 1.1 The purpose of this RFP is to solicit proposals with the intent to enter into a future contract with a qualified supplier to provide facility maintenance solutions and related services in the Southern California marketplace. Enterprise Rent-A-Car is examining several alternatives of providing these services and may decide, after reviewing proposals submitted, not to enter into any agreement.

SECTION 2 – GENERAL INFORMATION

2.1 Administrative Guidance:

The information provided herein is intended to assist Participants in the preparation of proposals necessary to properly respond to this RFP. The RFP is designed to provide interested participant with sufficient basic information to submit proposals meeting minimum requirements, but is not intended to limit a proposal's content or to exclude any relevant or essential data therefrom. Participants are at liberty and are encouraged to expand upon the specifications to give additional evidence of their ability to provide the services requested in this RFP.

2.1.2 Inquiries:

Inquiries should be submitted via email to paul.m.mcglynn@ehi.com prior to 4:00 p.m. PST on 3/11/2019. All questions will be consolidated and answers will be provided to all Participants on or by 3/16/2019.

2.1.3 Proposal Deadline:

Proposals are to be submitted via email to paul.m.mcglynn@ehi.com by 5:00 p.m. PST on 3/25/2019. Proposals received after this deadline will be late and may be deemed ineligible for consideration.

2.1.4 Program Effective Date:

The effective program date shall begin July 1, 2019.

2.1.5 Proposal's Effective Term:

All proposals shall remain valid for a minimum of 180 calendar days after the Proposal Due Date to allow adequate time for evaluation.

2.1.6 Contract Effective Term:

The anticipated Contract term will be for a period of three (3) years with an option to renew for two (2) additional periods of twelve (12) months.

2.1.7 Protected Information:

All material contained in and/or submitted with the proposal becomes the property of Enterprise Rent-A-Car.

2.1.8 Incurring Costs:

Enterprise Rent-A-Car will not be liable for any cost which participant may incur in connection with the preparation or presentation of their proposal(s).

2.1.9 Other Communications:

During the RFP process (from the date of issue through the date of contract award or other final decision) Paul McGlynn is the sole source of official information regarding this RFP. All other communications, both spoken and written, which are received by any representative of the supplier from other sources (such as employees in the using department) should be confirmed by the supplier with RFP as being true and accurate prior to incorporating such information into their response. This refers to both formal and informal conversations and communications. Significant changes to the RFP will always be issued as a formal, written addendum.

Alternative Proposals

A supplier may submit more than one proposal, each of which must follow the Proposal Response Outline (section 2.9 herein) and satisfy the requirements of this RFP. The supplier's primary proposal must be complete and comply with all instructions. The alternative proposals may be in abbreviated form following the Proposal Response Outline but providing complete information only for sections which differ in any way from those contained in the prime proposal. If alternative proposals are submitted, the supplier must explain the reasons for the alternative(s) and its comparative benefits. Each proposal submitted will be evaluated on its own merits.

2.1.10 Oral Presentation:

Enterprise Rent-A-Car may require an oral presentation by a supplier to supplement their written proposal. These presentations will be scheduled, if required, by Enterprise Rent-A-Car after proposals are received and prior to the award of the Contract.

2.1.11 Authorized Supplier Representatives:

Proposal: List the name, title, office address, telephone number and email address (if available) of the person(s) authorized to represent the supplier regarding the proposal(s) submitted in response to this RFP.

2.2 Remedies:

This RFP and all questions relating to its validity, interpretations, performance and enforcement shall be governed by and construed in accordance with the laws of the state of California. The parties hereby consent and submit to the jurisdiction of the federal and state courts of Orange County, California over any action at law, suit in equity or other proceeding which may arise out of this RFP. In the event that any party institutes any legal suit, action or proceeding against the other party arising out of or relating to this RFP, the prevailing party in the suit, action or proceeding shall be entitled to receive in addition to all other damages to which it may be entitled, the costs incurred by such party in conducting the suit, action or proceeding, including reasonable attorneys' fees and expenses and court costs.

2.3 Anti-Collusion:

The submission of a proposal constitutes agreement that the supplier has not divulged its proposal to, or colluded with, any other offeror or party to a proposal whatsoever.

2.4 Insurance:

The winning supplier will be required to maintain a comprehensive program of insurance covering its liability for personal injury (including contractual liability, errors and omissions, bodily injury, false arrest, libel, slander and similar torts).

2.5 Right to Reject:

Enterprise Rent-A-Car reserves the right to reject any or all proposals and to waive any informality or technicality in any proposal.

2.6 Relationship of the Parties:

In assuming and performing the obligations of any Contract, Enterprise Rent-A-Car and any supplier shall each be acting as independent parties and neither shall be considered or represent itself as a joint venture, partner or employee of the other.

2.7 Equal Opportunity:

No supplier of goods and/or services under this RFP or any Contract shall discriminate against any employee, applicant for employment, or recipient of services on the basis of veteran status, race, religion, color, sex, sexual orientation, age, disability, or national origin.

2.8 Debarment:

The winning supplier will certify that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction (contract), by any governmental department or agency.

2.9 Proposal Response Outline:

Submitted proposals must be concise, organized, and labeled in the following format:

2.9.1 RFP Participant Introduction:

The introduction should include a bio of the supplier's company, the name, address, and telephone number, of the person to be contacted along with a list of others who are authorized to represent the RFP Participant in dealing with this RFP. Any other information not appropriately contained in the proposal itself should also be included in the letter.

2.9.2 Executive Summary:

The executive summary should briefly describe the supplier's approach and clearly indicate any options or alternatives being proposed and should also indicate any major requirements that cannot be met.

2.9.3 Detailed Discussion:

This section should constitute the major portion of the Participant's proposal and must contain a specific response to answer each specific section of the Statement of Work.

2.9.4 Financial Reports:

The supplier should furnish a current financial report for the company's most recently completed fiscal year.

2.9.5 Miscellaneous:

Additional information and attachments, if any, may be included here.

SECTION 3 – Statement of Work.

Enterprise Rent-A-Car facilitated approximately 27,000 work order requests in the past 24 - month period. These work orders were dispersed throughout San Diego, Riverside, San Bernardino, Orange, Los Angeles, and Ventura Counties.

Below is a generalized listing of the scopes and types of services that the winning supplier will be expected to provide:

Services:

1. Provide a turn-key solution that will include a staff of vehicle-based trained technicians to maintain our 370+ Southern California locations in a timely manner. All vehicles, tools, parts, and supplies, will be provided by the contractor.
2. A local support team consisting of an account manager, safety, HR, accounting, training, and technology experts, to support our account.
3. Provide coordination and counseling of open work orders and self-perform as many repairs as possible. These work orders will be on an ad-hoc basis.
4. NTE's shall be respected and clear communication with field supervisors is a must.
5. Provide a web-based solution for submission or work orders by Enterprise Rent-A-Car employees. A solution that can also monitor warranties of assets and repair history is a plus.
6. In the case that your web-based solution is not used, you must have the availability to integrate your system with the CAFM system of our choice.
7. Provide updates and photos on submitted work orders and the repairs needed to resolve the problem at hand.
8. Provide monthly and annual reporting on work order completion percentage, time to complete work orders, cost of time and materials, outsourced repairs, van inventory, fuel, and mileage.
9. Provide reporting of work order frequencies by trade and provide recommendations to reduce the amount of repairs.
10. Management, tracking, and reporting, of all exception processes to align with client's preferred practices.
11. A process for conducting surveys on performance with our field employees.
12. Conduct quarterly PM visits to all sites. Inspection is to include but not limited to HVAC, lighting controls, signage, electrical, plumbing, car wash equipment, roof condition, windows/seals, and commercial vacuum systems.
13. During PM's, assess the condition of office furniture, carpet, paint, and other aspects of clients branding.
14. Be on-call for emergency repairs 24 hours per day, and a way for our employees to communicate those needs.
15. Order and manage inventory of truck stock; supplies needed for repairs. Replenish as needed.

16. Contractor shall comply with the Federal Occupational Safety and Health Act and all other applicable Federal/State government rules and regulations.
17. An ISO 9000-compliant quality assurance process to verify that Contractor is delivering the Services outlined in this RFP.

SECTION 4 – Participant Responses

- Description of any strategic changes your company has undertaken in the past three years, such as businesses acquired or divested, reorganizations, etc.
- Does your company operate under other names? If so, what are the names and addresses of such firms?
- Tax I.D. number(s) of your company(ies).

4.1.2 Geographical Locations (Attachment 4.1.2)

Create an attachment labeled Attachment 4.1.2 indicating your area of geographical coverage in which you and/or your subcontractors can supply the products and services considered under this RFP.

4.1.3 Financial Information (Attachment 4.1.3)

Create an attachment labeled Attachment 4.1.3 providing, as applicable; key audited financial statements, 10-K’s, and annual reports for the most recent year and for the most recent quarters.

4.1.4 References (Attachment 4.1.4)

Create an attachment labeled Attachment 4.1.4 providing customer reference details for two of your company's major corporate accounts.

4.2 Competitive Benchmarks:

4.2.1 Industry Leaders (Attachment 4.2.1)

Create an attachment labeled Attachment 4.2.1 identifying your organization's top two competitors for this RFP and tell how you measure your performance against them.

4.2.2 Financial Issues (Attachment 4.2.2)

Create an attachment labeled Attachment 4.2.2 providing information regarding any outstanding financial or contractual obligations that might restrict you from fulfilling your obligations to the eventual agreement.

4.2.3 Supplier Diversity Information (Attachment 4.2.3)

Create an attachment labeled Attachment 4.2.3 describing any of your organization's diverse certifications and/or relationships including a description of your organization's Diversity Program, as well as your organization's ability to provide Tier 2 diverse spend reporting, e.g. Minority, Women Owned, Disadvantaged Business Enterprise, Veteran.

4.2.4 Sustainability Information (Attachment 4.2.4)

Create an attachment labeled Attachment 4.2.4 providing information regarding your organization's sustainability program, including but not limited to:

- Sustainability program achievements.
- Active memberships and participation in environmental, green, sustainable organizations and efforts.
- Details of your Environmental Purchasing Program (EPP).

4.3 Supplier Capabilities:

4.3.1 Process and Account Management (Attachment 4.3.1)

Create an attachment labeled Attachment 4.3.1 to provide a complete description of the proposed support process, account management, etc. including, but not limited to:

- The names and qualifications of the personnel who will manage our account,
- Detailed relocation process information, invoicing process, turn times, continuous improvement, etc.

4.3.2 Service and Quality Assurance (Attachment 4.3.2)

Create an attachment labeled Attachment 4.3.2 describing your company's quality accomplishments including, but not limited to:

- Your customer survey program to measure satisfaction and provide documentation of same. Enterprise Rent-A-Car is especially and specifically interested in customer service scoring for their customers' relocation experiences; as indicated above in Reporting, customer service scoring and reporting are a key component of this RFP's selection criteria.
- Indicate any quality awards or quality certifications that your company has achieved and provide supporting documentation and background information about these awards and/or certifications.
- Describe in detail your company's process for handling complaints, compliments, and questions; include examples of each.
- Describe your company's customer service performance standards and indicate how these performance standards are monitored and measured and how they affect employees' compensation.
- Describe your selection process for your service providers, e.g., bonding, certification requirements, re-certification requirements, etc.
- Describe your organization's CI Program (Continuous Improvement).
- Describe your employee background check process.

4.3.3 Supplier Provider Network Compliance (Attachment 4.3.4)

Create an attachment labeled Attachment 4.3.4 describing your provider relationships including, but not limited to:

- Your certification that your provider network will comply with all employment-related laws and regulations and with the quality and service standards listed in the agreement.
- How you will take full responsibility to rectify the situations (e.g. terminate providers, pay penalty fees) if Enterprise Rent-A-Car is not satisfied with your provider network.
- Is your provider network “owned” or outsourced? If outsourced, who?

4.3.4 Proposal Details (Attachment 4.3.5)

Create an attachment labeled Attachment 4.3.5 describing your proposal(s) including, but not limited to:

- A complete description of your proposal including suggested term.
- Proposed pricing including terms, price change methodology (if any), etc. per service type (including mileage if applicable), applicable volume discounts, etc.
- Resources required from Enterprise Rent-A-Car.

SECTION 5 – RFP Terms and Conditions:

- 5.1 This RFP is both confidential and proprietary to Enterprise Rent-A-Car, and reserves the right to recall this RFP in its entirety or in part. RFP supplier participants cannot, and agree that they will not, duplicate, distribute or otherwise disseminate or make available this document or the information contained within it without the express written consent. Consent shall be granted only if provided by the “RFP Representative”. RFP supplier participants may make this document available to those employees who have a need to know its contents in order to participate in the preparation of this proposal and who are bound by contract to keep it confidential.
- 5.2 Participant shall not include or reference this RFP in any publicity without prior written consent from Enterprise Rent-A-Car which may be withheld for any reason within Enterprise Rent-A-Car’s sole discretion and which, if granted, shall be provided only by the individual listed in this document as the " RFP Representative".

- 5.3 Participant must provide all requisite information requested under this RFP by clearly and concisely responding to all points. Any proposal which does not fully and comprehensively address this RFP may be rejected. If there is additional information that is relevant to your organization's proposal, please include that information in your response marked as additional information; however, judiciously consider its relevance to this document before including additional information in your proposal(s). Proposals as submitted will be considered your organization's best and final response. Proposals submitted after the deadline date may not be considered.
- 5.4 Enterprise Rent-A-Car reserves the right in its sole discretion, to select Participant without incurring any liability, and the right to reject any or all proposals received without explanation. Further, while not preferred, Enterprise Rent-A-Car reserves the right to award separate contracts to different regional or national Participant in selected locations, or to allocate services between Participant however is deemed appropriate.
- 5.5 Enterprise Rent-A-Car may request additional data, discussion, etc. in support of proposals. Additionally, a survey may be conducted of any Participant under consideration to confirm or clarify any information provided, or to collect more evidence of managerial, financial and technical abilities, including but not limited to, meetings with and visits to current customers served by the Participant. Enterprise Rent-A-Car is not responsible for any costs incurred by Participant in the preparation of their proposal(s).
- 5.6 All responses to this RFP must be guaranteed to be valid for a minimum of one hundred eighty (180) days beyond the Deadline Date.
- 5.7 During this process, any questions or comments regarding this RFP in any respect must be e-mailed in the suggested format provided in Exhibit One to: paul.m.mcglynn@ehi.com . Contact with any other personnel to gain information regarding products, processes, services, etc. covered in this RFP, may disqualify Supplier from further consideration.
- 5.8 All responses must adhere to the RFP format as set forth herein. All response materials must be accurately labeled to identify the appropriate section and the question(s) being addressed. All materials are to be returned to paul.m.mcglynn@ehi.com .
- 5.9 Should your organization choose not to participate in this RFP, please destroy all the materials received and email paul.m.mcglynn@ehi.com .

- 5.10 Although Enterprise Rent-A-Car welcomes procedural questions about this Request for Proposal, please refrain from making inquiries about the evaluation of your proposal(s). All respondents will be notified as soon as a decision has been made.
- 5.11 Once the requested proposals have been received, all will be reviewed utilizing objective selection criteria.
